DESCRIPTION: **A Senior Caseworker provides professional social work involving the determination and recommendation of the need for services, and the formulation and implementation of plans to meet the individual problems of cases assigned. The functional duties are similar to those of the Caseworker, except that through training and experience, Senior Caseworkers have gained expertise to handle more complex problems and situations with less direct supervision. Under general supervision, a Senior Caseworker makes social studies to identify the need for social services, and renders social services to clients. The Senior Caseworker may supervise a small group of subordinate workers and volunteers. When assigned, the incumbent may be responsible for the unit during the absence of a Case Supervisor Grade B. Does related work as required.**

MINIMUM QUALIFICATIONS: **PROMOTIONAL QUALIFICATIONS: One (1) year of permanent competitive status as a Caseworker for one (1) year in the Niagara County Department of Social Services immediately preceding date of written test.**

**OPEN COMPETITIVE: Graduation from a regionally accredited college or university or one accredited by the New York State Board of Regents to grant degrees with a Bachelor's Degree and two (2) years of full-time satisfactory paid experience in social work with a public or private social agency adhering to acceptable standards.**
