## CARE SERVICES COORDINATOR (EARLY INTERVENTION PROGRAM)

## No 69-588 Examination Open to the Public

The examination will be held to establish an eligible list used to fill one current vacancy in the Niagara County Health Department and any other vacancy during the life of the list. The list established from this exam will supersede any existing list for this title.

<u>RESIDENCE REQUIREMENTS:</u> Candidates must have been legal residents of Niagara County for at least one (1) month immediately preceding the date of the written examination and such residency must continue until the time of appointment. Preference in appointment may be given to successful candidates who have been residents of the municipality in which the appointment is made. Non-residents may be required to become a resident of the appointing municipality if local law so states.

<u>MINIMUM QUALIFICATIONS</u>: Candidates must meet the following on or before the date of the written exam. If you do not meet these qualifications, your application will be disapproved and your filing fee will not be refunded.

Graduation from high school or possession of an equivalency diploma and one of the following:

- 1. Graduation with a Bachelor's Degree in a health or human services field; **OR**
- 2. Graduation with an Associate's Degree in a health or human services field **and** one year of experience in the provision of service coordination; **OR**
- 3. One (1) year of experience in service coordination and an additional year of experience in a service setting with infants and toddlers with development delays or disabilities; **OR**
- 4. Two (2) years of experience in service coordination activities as delineated in regulation.

## NOTE:

- 1. A human services field includes majors in social work, psychology, mental health, early childhood development, geron to logy, vocational and or psychological counseling, occupational therapy, physical therapy, therapeutic recreation, education, and nursing, etc.
- 2. Degrees must have been awarded by a college or university accredited by a regional, national, or specialized agency recognized as an accrediting agency by the U.S. Department of Education/U.S. Secretary of Education.
- 3. Verifiable voluntary and/or part-time experience will be pro-rated.
- 4. Service coordination is defined in regulation as "assistance and services provided by a service coordinator to enable an eligible child and the child's family to receive the rights, procedural safeguards and services that are authorized under the Early Intervention Program."

**SPECIAL REQUIREMENT:** Possession of a driver's license at time of appointment and throughout duration of employment.

**BACKGROUND INVESTIGATION:** Applicants may be required to undergo a State and national criminal history background investigation, which will include a fingerprint check to determine suitability for appointment. Failure to meet the standards for the background investigation may result in disqualification.

**<u>FEE WAIVERS</u>**: Waivers for the filing fee must be completed in full and submitted with required documentation or your application will be disapproved

**DRUG SCREENING:** Applicants may be required to undergo a drug-screening test to determine suitability for appointment in accordance with local policies. Applicants who test positive may be restricted from future certification.

APPLICATIONS MUST BE SUBMITTED ELECTRONICALLY OR POSTMARKED BY THE FILING DEADLINE. YOUR APPLICATION WILL BE DISAPPROVED IF PAYMENT IS NOT RECEIVED BY THE FILING DEADLINE.

<u>DUTIES</u>: The work of this position is to serve as a single point of contact to assure that infants and toddlers with developmental delays and disabilities and their families receive necessary services commensurate to their needs through care coordination and in dividualized family service plans (IFSP); have access to quality health services; increase the number of children receiving health assessments and follow-up diagnostic and treatment services; and otherwise promote the health of children by assisting in arranging and providing for preventive and primary care services for children and increasing the self-sufficiency of families as outlined under Title II-A of Article 25 of Public Health Law and its supporting regulations. Work is performed under administrative supervision. Does related work as required.

NOTICE TO CANDIDATES: The use of calculators is ALLOWED. Unless otherwise notified, candidates are permitted to use quiet, hand-held, solar or battery powered calculators. Devices with typewriter keyboard such as computers, spell checkers, person al digital assistants, address books, language translators, dictionaries or any similar devices are prohibited. Cell phones and smart watches are prohibited.

**SUBJECT OF EXAMINATION:** There will be a written test which you must pass in order to be considered for appointment. The written test will be designed to test for knowledge, skills, and/or abilities in such areas as:

- 1. Preparing written material: These questions test for the ability to present information clearly and accurately, and to organize paragraphs logically and comprehensibly. For some questions, you will be given information in two or three sentences followed by four restatements of the information. You must then choose the best version. For other questions, you will be given paragraphs with their sentences out of order. You must then choose, from four suggestions, the best order for the sentences.
- **Principles and practices of social casework:** These questions test for knowledge of the principles and practices used to provide casework services to individuals and/or families of all ages, backgrounds, and circumstances. Questions will test for application of this knowledge in various settings and will include such topics as assessment, monitoring and evaluating services, counseling, referrals, and advocacy.
- 3. <u>Interviewing</u>: These questions test for knowledge of the principles and practices employed in obtaining in formation from individuals through structured conversations. These questions require you to apply the principles, practices, and techniques of effective interviewing to hypothetical interviewing situations. Included are questions that present a problemarising from an interviewing situation, and you must choose the most appropriate course of action to take.

<u>TEST GUIDE</u>: The New York State Department of Civil Service has not prepared a test guide for this examination. However, candidates may find information in the publication 'General Guide to Written Tests' helpful in preparing for this test. <u>CANDIDATES NOTE</u>: You are responsible for completing all sections of the official application. To receive credit for experience on a job, basic information such as address, name and title of supervisor, hours in the work week, final salary, and duties performed by you, must be shown. Be very specific in explaining experience that will qualify you for the position sought. Ambiguity and vagueness will not be resolved in your favor. **EACH SEPARATE SHEET ATTACHED TO THE APPLICATION MUST BE SIGNED.** 

<u>MULTIPLE EXAMINATIONS SCHEDULED FOR THE SAME DAY</u>: If you have applied to take a written test announced by either one or several local jurisdictions (county, town, city) scheduled to be held on the same test date as this written test, you must notify each of the local jurisdictions no later than two weeks before the test date, so they can make arrangement for taking all tests at one test site. All examination for positions in State government will be held at a State Examination Center.

<u>COLLEGE ACCREDITATION</u>: Your degree must have been awarded by a college or university accredited by a regional, national, or specialized agency recognized as an accrediting agency by the U.S. Department of Education/U.S. Secretary of Education. If your degree was awarded by an educational institution outside the United States and its territories, you must provide in dependent verification of equivalency. You must pay the required evaluation fee.

COLLEGE CREDITS MUST BE VERIFIED WITH AN OFFICIAL TRANSCRIPT. If you have listed college or special courses on your application it will be necessary for you to submit an official transcript or special course certificate. Documents can be submitted electronically or in hardcopy format but must be on official letterhead or stationary. If these documents are not on file prior to canvassing/certification for vacant positions, your name will not be canvassed/certified and your name will be removed from consideration for all appointments.

This examination will be prepared and rated in accordance with Section 23(2) of the Civil Service Law. The provisions of the New York State Civil Service Law, Rules and Regulations dealing with preparation and rating of examinations, as well as establishment and certification of eligible lists for positions in the classified service will apply to this examination.
