Incumbent will be responsible for operating a high box cube truck to transport food to meal sites in bulk containers. May also be required to operate a motor vehicle in the transport of senior citizens to meal sites and other Office for the Aging programs. This is routine work involving responsibility for the safe, efficient transportation of the elderly to and from meal sites and other programs operated by the Office for the Aging. Participates in collection of voluntary contributions by passengers. The work is performed under the general supervision of the Head Van Driver. Does related work as required.

MINIMUM QUALIFICATIONS: One (1) year of experience in the operation of a motor vehicle. Must be able to routinely lift 50 lbs.

OFFICE OF AGING ONLY: One (1) year of experience in the operation of motor vehicles, six (6) months of which must have been in the operation of an 8 – 12 passenger van and/or a high box cube truck. Experience can be paid or unpaid. All candidates will be required to provide a statement detailing their experience operating this type of vehicle.

SPECIAL REQUIREMENT: Eligibility for a valid New York State Operator's License. Possession of license at time of appointment.
