MINIMUM QUALIFICATIONS: 1) Graduation from a regionally accredited college or university or one accredited by New York State Board of Regents to grant degrees with an Associate's Degree in electronics and two years of satisfactory experience in the maintenance and repair of Supervisory Control and Data Acquisition (SCADA) equipment; OR 2) Four years of satisfactory experience in the maintenance, repair and fabrication of electronic equipment, two years of which must have been in the maintenance and repair of Supervisor Control and Data Acquisiton (SCADA) equipment.
