This position differs from Assigned Counsel and Conflict Administrator by virtue of the lack of the following: supervisory responsibility of attorneys, development, implementation, and administration of procedures, and management of the daily activities of the Assigned Counsel and Conflict Administrator Office. The employee reports directly to and works under the general supervision of the Assigned Counsel and Conflict Administrator. Does related work as required.

MINIMUM QUALIFICATIONS: **Current registration as an Attorney for the State of New York at the time of appointment and for the duration of employment.**

Thorough knowledge of the principles and practices of criminal law applicable to State and Federal criminal laws; thorough knowledge of criminal court procedures and of the rules of evidence. A high degree of skill in the preparation of briefs, presentations of defense before a jury and the ability to analyze and apply legal principles, facts and precedent to legal problems.
