The incumbent conducts Federal Motor Carrier Safety Administration (FMCSA) required Entry Level Driver Training (ELDT). The work is performed under the general supervision of the Deputy Commissioner or other supervisory or administrative staff. The incumbent works closely with other department administrative and supervisory personnel implementing hands-on driver training, testing preparation and scheduling. Operates trucks in the hauling of construction materials and snow removal; operates snow plows and spreads salt; operates roadside mowing machines; may be assigned to the collection of refuse. The work is performed in compliance with all applicable rules, procedures, and Department of Transportation laws. Incumbents are required to perform manual labor work, flagging and/or traffic control when necessary, and are expected to be available to work overtime and/or shift work during nights, weekends and holidays.

MINIMUM QUALIFICATIONS:

1. Graduation from high school or possession of an equivalency diploma; AND
2. CDL License Class A or B and Two (2) years driving experience of commercial motor vehicles; OR
3. CDL License Class A or B and two (2) years experience as a trainer for behind the wheel operation of Commercial motor vehicles; OR
4. An equivalent combination of training and experience as defined by the limits of (A) and (B) above.
