Registered Nursing duties include: conducting nursing assessments related to mental health/substance abuse signs and symptoms as well as physical health concerns; completing treatment plans for assigned case load; conducting mental status, need for treatment, risk and lethality assessments; coordination with psychiatrists/NP/MDs on medication related issues; assisting clinic psychiatric personnel (including taking vitals, administering IM medications, gathering symptom information); consultation with therapists on case related issues and acting as liaison with clinic prescribers; crisis intervention and participation in the mobile crisis team, with occasional oncall responsibilities (2 -3 times per month). Program hours of operation are Mondays 8:30am – 7pm and Tuesday – Friday 8:30am - 4:30pm. Position is 35 hours per week.
