Incumbents who do not possess a CDL-B at time of hire, will receive classroom and field instruction on the safe operation of heavy single unit trucks over 26,000 GVWR. The training will involve situations that may occur in the normal operation of vehicles used at the Highway Division and will comply with all applicable rules, procedures, and Department of Transportation laws. The incumbent must complete the training and obtain a CDL-B within one (1) year of appointment. This position requires knowledge of the operation, repair, and maintenance of diesel powered, gasoline powered, hybrid and/or electric vehicles and/or equipment. Work requires a thorough knowledge of the trade. Instructions are received regarding tasks to be performed and work assignments. Does related work as required.
