This position is responsible for maintaining and repairing equipment at the wastewater plant, tributary pump stations and/or on the municipal wastewater distribution system. When required, supervises Wastewater Maintenance Person employees at the District.

MINIMUM QUALIFICATIONS: Graduation from high school or possession of an equivalency diploma and one of the following:

- Two (2) years of paid experience in the maintenance of wastewater treatment plant or related equipment* or the construction, maintenance or service phases of a distribution system; OR
- 2. Two (2) years of related specialized formal education beyond the required level.

<u>NOTE</u>: Related equipment shall include but not be limited to diesel, electric or gasoline driven equipment; chain, gear, belt, or direct drive mixer, conveyors, collectors, grinders, pumps, compressors, blowers, generators, boilers, structural repair equipment, welders, sprayers, sanders etc.

<u>SPECIAL REQUIREMENT</u>: Possession of a valid New York State Driver's License at time of appointment and for the duration of employment. For appointments at the Niagara County Sewer District, a CDL A or B with N endorsement is required within one (1) year of appointment and then for the duration of employment.
