Although the BHC/RS is able to consult on any CPS case, priority for direct service will be given to CPS preventive cases for families who may benefit from substance abuse screening and to assist in development, implementation and monitoring of the plan for Safe Care for infants born and identified as being affected by substance abuse, withdrawl symptoms, or Fetal Alchohol Spectrum Disorder. BHC/RS accompanies Child Protective Service Worker and/or preventive case worker to homes in community locations to provide assessment and screening where appropriate, referral to mental health, chemical dependency and developmental disability services. BHC/RS follows up on mental health interventions, further testing and assessments of the individual child and/or family. MINIMUM QUALIFICATIONS: <u>Graduation with a Master's Degree in Social Work, Mental</u> <u>Health Counselor, Marriage and Family Therapist, Creative Arts Therapist, or</u> <u>Psychoanalyst and eligibility for a limited permit.</u>

MINIMUM QUALIFICATIONS AT TIME OF APPOINTMENT:

1. Possession of one of the following: Current New York State license, provisional license, or limited permit as a Master of Social Work, Mental Health Counselor, Marriage and Family Therapist, Creative Arts Therapist, or Psychoanalyst; OR
