MINIMUM QUALIFICATIONS: 1. Graduation with a Bachelor's Degree or higher in a natural science, a forensic science, an engineering science, or criminalistics; OR

2. Graduation with a Bachelor's Degree or higher, which must have included at least twelve (12) credit hours in one of the natural sciences, forensic sciences or engineering sciences AND one of the following:

a. One (1) year of full-time or its part-time equivalent experience in a forensic laboratory which must have included the examination of firearms; OR

**b. Successful completion of an internship with a minimum of one hundred (100) hours in a forensic laboratory; OR**  
**3. An equivalent combination of training and experience that is defined by the limits of 1,2, and 3 above.**

**SPECIAL REQUIREMENT: Applicants will be required to undergo a state and national criminal history background investigation which will include a fingerprint check to determine suitability for appointment. Failure to meet the standards for the background investigation may result in disqualification.**

**NOTE: 1. Degrees and college credits must have been awarded by a college or university accredited by a regional, national, or specialized agency recognized as an accrediting agency by the U.S. Department of Education/U.S. Secretary of Education; 2. Incumbents must pass a competency test prior to assuming casework responsibility, and must pass a proficiency test annually, in accordance with accreditation requirements. Additional continuing education and training may be required as condition of employment.**
