The term of traineeship is limited to two (2) years, during which time employees will be required to satisfactorily complete the training and experience requirements of the State Health Department to obtain a Public Health Technician II certification. If the employee fails to obtain this certification within this two (2) year traineeship, his/her employment will be discontinued. Trainees who receive this certification automatically will be promoted to the Public Health Technician II title without further examination and will not be required to complete the full two-year traineeship.
