Responsibilities involve legal representation of indigent persons entitled to public defense who cannot be represented by the Public Defender's Office due to a conflict of interest. This position differs from Assigned Counsel and Conflict Administrator by virtue of the lack of the following: supervisory responsibility of attorneys, development, implementation, and administration of procedures, and management of the daily activities of the Assigned Counsel and Conflict Administrator Office. The employee reports directly to and works under the general supervision of the Assigned Counsel and Conflict Administrator. Does related work as required.

MINIMUM QUALIFICATIONS: Current registration as an Attorney for the State of New York at the time of appointment and for the duration of employment.

SPECIAL REQUIREMENT: Candidates must have a valid license to operate a motor vehicle in New York State or otherwise demonstrate your capacity to meet the transportation needs of the job at time of appointment and for duration of employment.
