This senior leadership level position is responsible for the management and strategic planning of a local health agency including the coordination of the various technical services provided under the auspices of a public health agency. Medical consultation and direction are obtained from a contracted health officer. This position is responsible for policy development and oversight, budgeting, program design, directing, and implementation of all public health information, infrastructure, and programs. This position serves as the Chief Public Health Officer for Niagara County and is the Chief Spokesperson for the Niagara County Department of Health. Prior experience in government and public health administration is preferred.

MINIMUM QUALIFICATIONS: A Public Health Director shall possess a Master's Degree in public health or related field and three years of public health administration experience, or an appropriate combination of education and experience deemed equivalent by the State Commissioner of Health.

SPECIAL REQUIREMENTS: All appointments to the position of Public Health Director and the arrangements for the medical consultant are subject to the approval of the State Commissioner of Health.
