Registered Nursing duties include: Conducting nursing assessments related to mental health/substance abuse signs and symptoms as well as physical health concerns; completing treatment plans for assigned case load; conducting mental status, need for treatment, risk and lethality assessments; coordination with psychiatrists/NP/MDs on medication-related issues; assisting clinic psychiatric personnel (including taking vitals, administering IM medications, gathering symptom information); consultation with therapists on case-related issues and acting as liaison with clinic prescribers; crisis intervention and participation in the mobile crisis team, with occasional on-call responsibilities (2-3 times per month). Program hours of operation are Mondays 8:30am – 7 pm and Tuesday – Friday 8:30am – 4:30pm. Position is 35 hours per week. Niagara County offers exceptional benefits, including a supportive team environment, low cost, high-quality health insurance, participation in the NYS Pension/Retirement system, contractual raises, and generous time off!
