The incoming Deputy Commissioner will have the opportunity to lead challenging, high-impact transportation, and capital improvement projects that advance the County's infrastructure priorities. Candidates should bring responsible engineering management experience, particularly in highway and/or bridge engineering, along with an active P.E. license.

MINIMUM QUALIFICATIONS: **Candidates must meet one of the following qualifications:**

1. Graduation from a regionally accredited college or university or one accredited by the New York State Board of Regents to grant degrees with a Bachelor's Degree in mechanical, civil, or electrical engineering AND four (4) years of full-time paid experience in the engineering field, two (2) of which must have been responsible engineering management experience. Two (2) years of experience must have involved highway and/or bridge engineering; OR

2. Six (6) years of full-time paid experience in the engineering field, three (3) of which must have been responsible engineering management experience. Three (3) years of experience must have involved highway and/or bridge engineering.
