This position works as a member of a multi-disciplinary clinical treatment team providing a total therapy program individually tailored for persons with mental health, substance use and/or developmental disability needs. Incumbents serve as the medical and psychiatric nursing care specialists on a treatment team consulting with and advising team members; coordinating treatment efforts with program staff and contractual prescribers (psychiatrists and nurse practitioners); developing and carrying out a treatment plan for a caseload of clients. This position is distinguished from other Registered Professional Nurse positions by its role as primary nursing care specialist to a caseload of clients who experience mental health, substance use, and/or developmental disability concerns and their family members.. The incumbent is recognized as the Qualified Health Professional assigned to the case and thus is

subject to rules stipulated by the Office of Mental Health and other state/federal oversight bodies. Does related work as required.

MINIMUM QUALIFICATIONS: One (1) year of paid experience in one of the following: A supervised behavioral health setting such as mental health, developmental disabilities, alcohol or substance abuse related services; aging services working with alzheimers and dementia; hospice-type services working with depression and grief; hospital emergency department; and/or a correctional facility.

NOTE: Part-time experience will be pro-rated towards meeting the experience requirement.

SPECIAL REQUIREMENTS:

License and current registration to practice as a Registered Professional Nurse in New York State at time of appointment and throughout the duration of employment.
